

#### **IGNOROMICS**

#### THE ECONOMICS OF IGNORANCE

The other day, while perusing a *New York* Times graphic that showed the huge number of poverty spots on a map of the United States, I had a sudden realization of how stupid poverty is. It is simply irrational. There is no REASON for poverty to exist on the planet. It exists because of the lack of REASON. Hence this issue of *Thoughtline*.

This vision generates defacto systems like the Divine Right of Kings and the notion that the planet and everything on or in it was the "property" of those who occupied the top of the Hierarchy. Of course, this view included all those human beings who were lesser than the rulers. Slavery is actually a built in cornerstone of this vision.

When, for example, a 10<sup>th</sup> century king referred to his subjects, he was not talking about his equals, his brother or sister human beings, he was referring to his property as was the king of kings, Ozymandias.

(I place this little poem here because it is an image of exactly what humanity is rushing pell-mell toward... but I get ahead of myself.)

Traditionally, economics is considered to be "the science of the utilities or the useful application of wealth or material resources; the study of the production, distribution, and consumption of goods and services of a nation or region, and its effect on the wealth of a country." *Webster Dictionary.* This, in my view, is more aptly defined in the *Wiktionary* as "the study of resource allocation, distribution, and consumption of capital and investment; and the management of the factors of production." In either case, it is considered to be a "Social Science" rather than a "Hard Science."

However, regardless of how economics is classified. the pronouncements predictions of most of its gurus, authorities, professors, and pundits—the vast majority of whom have been immersed in the illusion of materialism which I outlined above—concerning the health and welfare of the planet have exercised enormous power over the evolution of the planet and the planet's primary driver, humanity, for a very long time. The individuals making these predictions achieve the status of authority through the acquisition of documents, awarded to them by others who already hold such documents, that indicate he or she is an expert, or an authority in this particular field of study. Whether their opinions, predictions, assumptions, post the acquisition of their documents of authority, have proved to be accurate or not is seldom considered in evaluating the next guesses they make.

The pronouncements and the further predictions of future events by these various individuals are based on their research and analysis of various current events. The events are viewed as the result of what has been done before in the general area of the use and application of "wealth and material resources." In the effort to make their analysis appear to be "scientific", these prognostications of the future, put forth with authority, are based on artfully

organized, intellectual research, accompanied by statistical devices, formulas, graphs and curves to support interpretations and assumptions regarding why what has happened in the past has happened.

Other than the weight they gain by being voiced or published by a documented authority these figure, pronouncements and predictions. unlike sav the Combined Gas Law of physics, have little or no substance. The evidence "proofs" backing conclusions required in hard science are nonexistent. Theories, such as free market, laissez-faire capitalism, trickledown economics are not the same as Pi.  $\pi$ . They are simply the opinions, actually the guesses, and frequently the manipulations for an end, of why various things unemployment like inflation happen and what possibly could happen in the future.

The factor that comes powerfully and unavoidably into play--in any science and especially in the social or soft sciences such as economics, political science, psychology, sociology and so forth--is one's personal opinions and point of view regarding the nature of reality. Lacking the disciplines, the objective, impersonal approach of scientific inquiry, and the physically verifiable proofs of "hard science" the proofs put forth by many of these authorities mostly masquerade as "evidence". The research, analysis, and

conclusions are frequently driven one's personal, frequently political, and self promoting agendas, and personal, usually unconscious, conceptions Reality.

For example, consider the economic plans and federal budget plans put forth by Senator Paul Ryan, Chairman of the House Budget

Committee. Or consider this comment. George Riesman, in an article "The General Benefit from Reducing Taxes on the Rich" says, "Of course, many people will characterize the line of argument I have just given as the 'trickledown' theory. There is nothing trickle-down about it. There is only the fact that capital accumulation and economic progress depend on saving and innovation and that these in turn depend ["depend on" means are the result of] the freedom to make high profits accumulate great wealth. The only alternative to improvement for

all, through economic progress, achieved in this way, is the futile attempt of some men to gain at the expense of others by means of looting and plundering. This, loot-and-plunder theory, alternative advocated by the critics of the misnamed trickle-down theory."

huge part in what one's analysis reveals. For example, it was not hard for the tobacco industry to find individuals with the necessary PhDs to prove that smoking cigarettes was not damaging to health or for various religious organizations find documented to authorities to prove that global warming is not caused by how humans live. field of economics is and has been especially vulnerable to these two factors.

The assumptions regarding the nature of reality held by most of these individuals are irrational. Or, one might say, it is an ignorant vision of reality. This vision of Reality, however, is the lens through which Ignoromists only not but analyze. actually choose their data.

The Greater few, or People of Quality as they referred to themselves. considered these imbalances to be their normal condition and viewed them righteous proof of their superiority.

With gradual advances in education and improving communications techniques. the obvious absurdity of this situation is slowly beginning to registered by some of the ordinary people. Because of our current electronic communications systems and the Internet the average citizen of any country may be of the world-around aware scope and grossness of the imbalance which is causing their daily suffering. However, they are mainly bewildered and do not have a conscious realization that the conditions are wrong, stupid, and against the basic laws of

In the New York Times article on January 2, "High Rollers in a Buying Mood" we learned that Matt Hlavin, an entrepreneur Cleveland who owns businesses, bought three Mercedes last year: a \$237,000 SLS AMG and a \$165,000 S63 AMG for himself, and a \$97,000 GL550 sport utility vehicle for his wife. If this expenditure startles you, it is an indicator that you are not aware of the scope of the imbalance. Mr. Hlavin's point of view is that the \$427,067 is really "not that much". "I look at it as. I don't have a boat."

For those in the owners of a boat and probably a couple of planes as well category, Roll Royce offers a bit of an upscale car selection: There is the Ghost for \$300,000, the Wraith, a performance car, for \$340,000 and then the Phantom, which has a base price of \$402,940 and is designed for use with a chauffeur.

(The **national** average price of a 4 bedroom house with 2 bathrooms is \$292,152.)

Eric Shepherd, Rolls-Royce's president for North America, said that for many potential buyers in the six-figure market, the barrier to buying wasn't an issue of dollars but of cultural sentiment. "Our customers never lost the ability to buy," he said. "They may have lost the appropriateness to buy."

The article indicates that luxury, which was seen as a bad word several years ago is O.K. again, and it is now deemed appropriate to buy.

These examples may seem extreme, but they are petty when one looks at the data regarding the actual use and distribution of world wealth. Mr. Hlavin, for example is light years away from being a member of the world's billionaires who numbering "just 497 people (approximately 0.000008% of the world's population) were worth \$3.5 trillion (over 7% of world GDP).

# For The Not So Great and the Lesser Ones:

- Number of children in the world.2.2 billion
- Number of children in poverty. 1 billion, that is every second child.
- ➤ Almost half the world over three billion people live on less than \$2.50 a day. (Again if it seems ridiculous that someone can live on \$2.50 a day, it indicates that you are not aware of the real situation on the planet.)
